



Direct Deposit/ Electronic Funds Transfer Enrollment

Please take this opportunity to participate in our Direct Deposit program. This program is part of our continuing effort to provide the best customer service to our owners. Some benefits of direct deposit are the elimination of mailing delays, lost or stolen checks and receipt delays related to address changes. Direct Deposit will allow our interest owners to receive an electronic funds transfer (EFT) in their designated financial institution (bank, credit union or savings and loan) at no cost to you. The EFT will deposit the cash value of your monthly interest payment into your bank account and is available for use within one (1) business day following the check issue date using the Automated Clearing House (ACH) wire system. It is faster, more convenient and efficient, plus, no more waiting to receive your check.

Only one form is required per owner number (not per well.)

If you choose to receive your payments electronically, you will no longer receive your check detail by mail. Your check detail will be available to view and print at www.energylink.com (1-888-573-3364) on the check issue date, free of cost to you. In order to begin receiving Electronic Payments, please fill out the form that is included and attach a voided check.

The Authorization Form can be used for both the initial sign-up process and to change existing information in the future.

If you elect not to participate in our Direct Deposit program, simply disregard this letter. No further action is necessary.
